Saint Kitts and Nevis is a two-island country Located in the West Indies and is a commonwealth realm with Queen Elizabeth II as head of state.

The citizenship by investment program of Saint Kitts and Nevis was established in 1984 making it the longest-established economic citizenship program worldwide. Since then, the country has continued to lead the economic citizenship industry and has made it its goal to represent the 'Platinum Standard' of citizenship by investment. Today, the Saint Kitts and Nevis Program stands as the oldest, most trusted, and most successful program of its kind.



Benefits

Visa Free Travel to UK & Schengen:

As a citizen of Saint Kitts and Nevis, you gain access to visa free travel to 133+ countries, with more countries being constantly added to the list, including all countries in the Schengen area as well as major countries in Latin America, North America and Asia. Should you travel anywhere outside these countries, the Saint Kitts and Nevis passport will facilitate and ease the process of obtaining a visa in most countries.

Saint Kitts and Nevis passport valid is for 10 years and for 5 years for children below 16.

Tax & Business Advantages:

Saint Kitts and Nevis passport holders benefit from an attractive tax regime:

No foreign income, wealth, gift, inheritance, or capital gains tax.

Furthermore, the benefits include tax free trade with

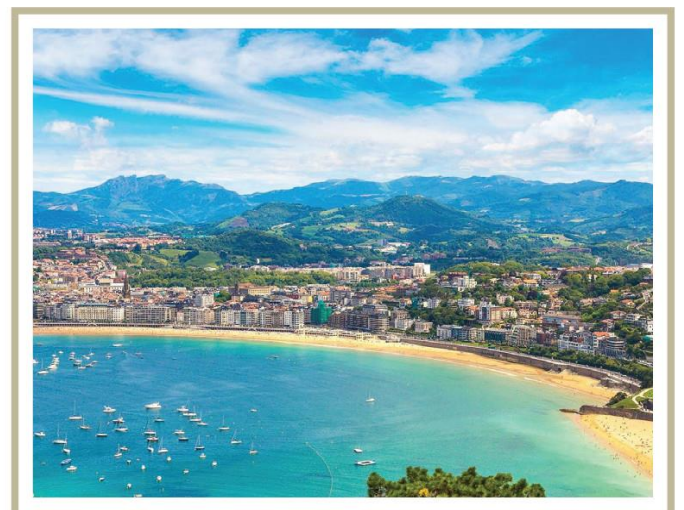
Canada and duty-free trading in the whole of the Caribbean.

The VIP / 60 Day Process

The Accelerated Application Process (AAP) approved by the Government of Saint Kitts and Nevis in October 2016 allows applications with the Citizenship by Investment Program to be accelerated to a 60-day processing period. Applying using the AAP can see an application completed within 60 days with some applications completed in as early as 45 days.

AAP Process Fees (inclusive of due diligence fees)

- Main Applicant: US \$25,000.00
- Dependent >16 years of age: US \$20,000.00



Investment Options

There are two different investment options, which serve as a qualifier for your application to the Saint Kitts and Nevis citizenship program.

Option 1

Contribution to the **Sustainable Growth Fund (SGF)**

- For a single applicant: **US \$150,000** (non-refundable)
- For a family of up to 4: **US \$195,000** (non-refundable)
- For each additional dependant, regardless of **US \$10,000** (non-refundable) applies.

Option 2

Investment in pre-approved real estate projects, which can include hotel shares, villas and condos:

- **US \$200,000** minimum investment (resalable after 7 years)
- **US \$400,000** (resalable after 5 years)

*Plus government processing fees and due diligence fees

Steps and Procedures

Month 1

Step 1:

Client chooses either investment or donation option. Client signs the **Huriya** contract, and pays initial retainer.

Step 2:

Huriya assists the client to gather all required documentation, and to complete the various Government application forms for submission to the CIU.

Step 3:

Second payment is made, and file is submitted.

Month 2-4

Step 4:

Issuance of **Approval** letter by the CIU (Citizenship-by-Investment Unit), third payment is required immediately.

Step 5:

Naturalization certificate is issued

Month 5

Step 6:

Huriya Private receives client passport(s). Passport can be either picked up from **Huriya Private** office or delivered to clients home address, (locally or internationally).
